# First 5 California and Partner Organizations Distribute Emergency Supplies to Sacramento Child Care Providers

**SACRAMENTO, Calif. (January 23, 2021)** – Partnering organizations including First 5 Sacramento County, Child Action, Inc. and SupplyBank.Org convened on Saturday to host a drive-thru supply distribution event for 350 local child care providers as part of the First 5 California Emergency Supplies Program. Recognizing that child care providers were struggling due to the pandemic, First 5 California initially launched the program with a \$4-million-dollar investment to fund emergency supplies for all 58 county First 5 commissions in the state and has since increased the program to \$5 million.

To date, the statewide program has distributed 6.3 million diapers, 8.8 million baby wipes, 6.6 million masks, 3.9 million disposable gloves, 11,745 infrared thermometers, 317,500 units of hand sanitizers and soaps and other items, with more on the way.

The program serves child care providers and other community based agencies serving the broader needs of many children and families, including those in Sacramento County. Since the start of this program, Child Action, Inc. has implemented local distribution by holding 13 distribution events, reaching 1,000 child care providers.

“The program addresses the ongoing shortages and urgent demand of essential supplies for child care providers and the community,” said Camille Maben, executive director of First 5 California. “Our efforts are providing local county commissions support for reducing community spread and detecting symptoms as early as possible, which is why we are pleased to be distributing nearly 11,000 infrared thermometers to essential service providers remaining open during the pandemic.”

To facilitate the purchase and distribution of these supplies, First 5 California is working in conjunction with SupplyBank.Org—a California-based nonprofit that specializes in leveraging bulk purchasing power and innovative supply chain strategies—to provide low-cost supplies to organizations supporting low-income and vulnerable populations.

“We’re excited to be able utilize our model to address the emergency needs with our allied agencies in Sacramento County and throughout California,” said Benito Delgado-Olson, founder and executive director of SupplyBank.Org. “We are grateful for the partnership and leadership of First 5 California, First 5 Sacramento, and all other contributors for joining the effort to reduce the spread of COVID-19 and ensure all families have health, safety and comfort during this unprecedented time.”

In the last year, First 5 Sacramento distributed approximately \$12 million a year in Prop 10 revenues to programs and services that meet local needs in Sacramento County. All 58 counties have a First 5 Children and Families Commission providing unique local services for that county.
